QUESTION ONE

Players in an evening session like to play as many boards as possible to a maximum of 32. What movement would you use for the following number of tables **and** how many boards will be played? (Give separate numbers for NS and EW should they be different.)

Name **one only** movement for each number of tables.

a) 12 tables

b) 7 tables

c) 11½ tables

d) 6 tables

(e) 9½ tables

(f) 14 tables (1 set of boards available. Do not use 2 board rounds.)

QUESTION TWO

The first round of a session has started when another pair arrives. Club policy is to make them welcome. What changes would you make had you started with each of the following movements? The maximum number of boards to be played is given in brackets.

a) 12 tables set up as a Share & Relay Mitchell; 3 boards per round (36)

b) 4½ table Howell; 4 boards per round (36)

c) 7 tables set up as a Mitchell movement; 4 boards per round (32)

d) 10½ tables set up as a 1½ Appendix Mitchell; 3 boards per round (30)

QUESTION THREE

(a) Give the order in which the NS pairs are displaced by the roving pair in a 12½ table movement using a Skip Mitchell.

(b) Does curtailing the above movement create any scoring difficulties for manual scoring (no computer)? YES / NO Explain your answer.

QUESTION FOUR

The first two columns show the starting positions of boards and pairs for Round 1 of an 11 table Appendix Mitchell movement. Enter pair numbers and board set after the first move in the Round 2 columns.

QUESTION SEVEN

On the diagram show positions of teams and boards for the first match of an 8 team New England Movement, 5 board rounds. Draw arrows to show how boards and players will move after the first match.

QUESTION EIGHT

You have planned a two session pairs event for 10 tables. 30 boards are to be played each session in a Share & Relay movement. For the first session everything goes to plan. Some players are switched for the second session and scores are to be added to produce one winning pair.

(a) A power failure towards the end of session 2 causes the movement to be curtailed by one round. Explain how scores will be compared.

(b) One NS pair does not turn up for the second session so there is a sit out for all EW pairs. Explain how scores will be compared.

QUESTION NINE

Matchpoint these boards. Make any corrections you feel entitled to make given that you cannot contact players about apparently wrong scores.
