J) During the auction West withdraws a bid that shows spades and another unspecified suit. May the eventual declarer, North, prohibit the opening lead of a diamond?		
K) Is an alert that is not required by regulation classed as unauthorised information?		
L) Is information from withdrawn calls authorised to the non-offenders?		
M) Declarer calls for a card that is not in the dummy. May they now call for any card that is?		
N) East has the ♣8 on the table as a minor penalty card? Is he required to play that card at the first legal opportunity?		
O) May a player ask a question solely for partner's benefit?		
P) May an insufficient bid be replaced with a double?		
Q) A player holds one card only of the suit lead. May they pause as though considering which card of several they wish to play?

East now plays ♠AKQ discarding 2 hearts from the dummy and ruffs a spade. She ruffs a diamond and on the last spade she discards another heart from the dummy before, surprisingly, North ruffs with the ♣Q and cashes one heart trick.
